SUBJECT: STATEWIDE FOSTER CARE ELIGIBILITY TRAINING

The purpose of this letter is to inform county welfare and probation departments of the statewide Foster Care Eligibility Trainings sponsored by the California Department of Social Services (CDSS) in preparation for the upcoming Title IV-E review to be held July 26 through 31, 2015. The trainings will be held from 9:00 a.m. to 4:00 p.m. as follows:

- May 13, 2015 in Orange
- May 21, 2015 in Sacramento

All counties should send the appropriate staff to this training to ensure that they are aware of their responsibilities in preparing for the review. This year there are a larger number of waiver counties (nine) which means that more non-waiver counties will likely be involved in the review.

- Logistics of the Audit Process
- Preparing County Files for Review
- Court Orders
- Aid to Families with Dependent Children-Foster Care Eligibility
- Relative Approvals
- Licensing
