## SUBJECT: ON-LINE AVAILABILITY OF DATA REPORT FORMS

The California Department of Social Services (CDSS) is pleased to announce the online availability of selected statistical data report forms. The forms are in Excel format and are designed for counties to download, complete, and mail electronically to the CDSS Data Systems and Survey Design Bureau (DSSDB). This new process should simplify county data reporting by eliminating manual reporting, providing automatic calculations for certain data fields, and applying data validations that will identify potential discrepancies before report forms are submitted to DSSDB. Once a report has been completed, it can be electronically submitted to a pre-programmed e-mail address with the touch of a single button.

Now available are the following report forms.

- The Adult Protective Services and County Services Block Grant Monthly Statistical Report (SOC 242)
- Three CalWORKs report forms. Because the data in these forms are interdependent, all three are linked together in one single Excel workbook. These report forms are:
  - 1. California Work Opportunity and Responsibility to Kids (CalWORKs) Cash Grant Caseload Movement Report (CA 237 CW);
  - 2. CalWORKs Report on Reasons for Discontinuances of Cash Grant (CA 253 CW); and
  - 3. CalWORKs Report on Reasons for Denials and Other Non-Approvals of Applications for Cash Grant (CA 255 CW)
- The Licensing of Facilities for Children Monthly Statistical Report (LIC 181)
