SUBJECT: ADOPTION ASSISTANCE PROGRAM (AAP) REGULATIONS

REFERENCE: All County Letters 09-51, AND 10-08

This letter is to notify agencies of the recent changes to the AAP regulations. The amendments ensure consistency with federal mandates and clarify current policy specific to: AAP eligibility; AAP payment amounts; AAP agreements; AAP reassessments; and nonrecurring adoption expenses. The revised regulations were finalized and submitted to the Office of Administrative Law (OAL) for publication on September 29, 2011 and became effective on December 10, 2011.
