- SUBJECT: AID TO FAMILIES WITH DEPENDENT CHILDREN-FOSTER CARE (AFDC-FC) AND KINSHIP GUARDIANSHIP ASSISTANCE PAYMENT (Kin-GAP) PROGRAM RATES
- REFERENCE: ALL COUNTY LETTER (ACL) NO. 01-55, SENATE BILL 68 (Chapter 78, Statutes of 2005) AND SENATE BILL 77 (Chapter 38, Statutes of 2005)

The purpose of this ACL is to provide current information on foster family home standardized basic rates, kinship guardianship assistance payments (KinGAP) program rates, foster family agency rates, intensive foster care program rates, specialized care increments, clothing allowance, State supplemental clothing allowance, infant supplement, and group home rates. The current State-approved rates for out-of-home placements and Foster Care support programs are provided in this ACL.

FOSTER FAMILY HOMES (FFH)

Following are the AFDC-FC standardized basic rates for FFHs and small family homes.

Except as specifically noted in this ACL, any county choosing to pay a rate higher than the State-approved basic rates indicated above shall pay any excess dollar amount using county-only funds. Counties should be aware that the Basic Rate also applies to children who are receiving Adoption Assistance Program (AAP) benefits.

KINSHIP GUARDIANSHIP ASSISTANCE PAYMENTS (KinGAP) PROGRAM

Section 11364 of the Welfare & Institutions (W&I) Code provides for Kin-GAP Program rates paid on behalf of eligible children at an amount equal to 100 percent of the basic rate paid to a licensed or approved FFH. Please refer to the Family Homes Schedule of Basic Rates on page 1 for the Kin-GAP Program rates.

FOSTER FAMILY AGENCIES (FFA)

The following charts provide the basic rates and components for treatment and nontreatment FFAs. It is the responsibility of the FFA to forward copies of its Rate Notification Letter to all agencies from which it receives placements.

SPECIALIZED CARE INCREMENTS (SCI)

There are no changes to the specialized care increment rates and they remain as in effect on July 1, 2001. As a reminder, a child can receive AAP benefits that include a specialized care increment.

CLOTHING ALLOWANCE

There are no changes to the county clothing allowance programs. Rates remain as in effect on July 1, 2001.

STATE SUPPLEMENTAL CLOTHING ALLOWANCE

In accordance with SB 77 (Chapter 38, Statutues of 2005), counties may continue to provide the \$100 State supplemental clothing allowance per child per State fiscal year to supplement the counties' existing clothing allowances. The State supplemental clothing allowance shall be provided to every child placed in FFHs and certified homes of FFAs, including those children receiving Emergency Assistance (EA) – Child Welfare Services.

INFANT SUPPLEMENT

There are no changes to the infant supplement rates. Children who are in receipt of Kin-GAP benefits are also entitled to receive the infant supplement. The following chart provides the Infant Supplement rates.
