SUBJECT: 1987/88 AID TO FAMILIES WITH DEPENDENT CHILDREN-FOSTER

CARE (AFDC-FC) COST-OF-LIVING ADJUSTMENT (COLA)

### FAMILY HOMES

The Fiscal Year (FY) 1987/88 Budget Act does not provide for a COLA for AFDC-FC funded family homes. There is no COLA for family home basic rates, specialized care increments or clothing allowances. The FY 1987/88 AFDC-FC standardized basic rates for family homes consequently remain at the following prior year levels:

#### GROUP HOMES

The 1987/88 Budget Act does not provide for a COLA for AFDC-FG funded group homes. As a result, Manual of Policies and Procedures (MPP) Section 11-402.17(2) does not apply for FY 1987/88.

## FOSTER FAMILY AGENCIES

The Budget Act provides a maximum 2.6% COLA for foster family agencies (FFAs). FFAs whose existing rates are below or equal to the amount calculated by using the methodology specified in MPP Section 11-403(d) will receive a COLA increase. No COLA is available for those FFAs whose existing rates exceed the amount calculated by using the MPP Section 11-403(d) methodology.



#### AFDC-FC RECIPIENTS WHO ARE REGIONAL CENTER CLIENTS

The 1987/88 Budget Act does not provide for a COLA for regional center established esidential roces. Therefore, the rates that were implemented on July 1, 1987 as about 47 to provisions of AB 2500 (Chapter 355, Statutes of 1986) for AFDC-FC mildies with are also regional center clients will remain unchanged.
