CALIFORNIA FOOD ASSISTANCE PROGRAM (CFAP) REPORTING

REFERENCE: ALL COUNTY INFORMATION NOTICE I-52-97, dated August 19, 1997

ALL COUNTY LETTER (ACL) 97-50, dated September 3, 1997

ACL 97-77, dated December 11, 1997 ACL 97-84, dated December 31, 1997

California implemented the CFAP on September 1, 1997. As transmitted in ACL 97-50, the California Department of Social Services received a six-month approval from the Food and Nutrition Service (FNS) for a temporary benefit calculation methodology to determine the federal and state share of benefits for CFAP. This methodology expired on February 28, 1998. Counties were advised in ACL 97-84 (December 31, 1997) to use a new budget methodology to calculate the actual federal and actual state coupon value for the CFAP.

As a result of the new budget methodology, counties will now report on the DFA 256 -Food Stamp Program Participation and Coupon Issuance Report the actual federal and actual state benefit amounts issued to households composed of federal and state persons. This is a major change from the previous six months whereby counties only had to report the total benefit amount issued to these combined households. Beginning in March 1998, counties are to report on the DFA 256, Line 3 - Value of Documented Coupon Issuances, in the Federal/State column, the actual federal and actual state amounts issued during the month to these combined households. The DFA 256 report will be revised to reflect this change. Until the form is revised, counties should report on Line 3 of the DFA 256 report, in the Federal/State column, both the actual federal and actual state amount issued to combined households during the report month.

As a reminder, the DFA 256 is due by the 20th day after the report month. Counties that have not submitted their reports for the months of September 1997 - January 1998 should do so immediately.

Further information and reporting instructions concerning CFAP will be issued in a subsequent ACL.
