Mr. ^{Rick}Carroll,

Please accept this document as El Dorado County Department of Social Services' Welfare-To-Work (WTW) Grant Matching Funds Addendum for FY 01/02. I believe that you will find it consistent with the 8/17/01 All County WTW Coordinators Letter.

1. The names of the WTW Grant operating entities working with each county.

Our Department facilitated the Governor's 15 % Discretionary Funds WTW Grant during the period of 9/30/98 through 6/29/01. During this same period, the local Workforce Investment Agency (WIA, formerly JTPA), named Golden Sierra, was also facilitating an 85% WTW Grant.

For the current 01/02 fiscal year, we are no longer coordinating any grant-related services with other entities. Rather, we are simply making WTW Grant Matching Fund eligibility determinations with former foster youth, ages 18 to 25.

2. A description of the collaboration and coordination between counties and operating entities to ensure services are not duplicated.

Prior to the current fiscal year, our collaboration with the local WIA agency included referrals between the two grant services and regular staff meetings with the involved grant coordinators and case management staff.

Efforts to coordinate services to non-custodial parents were unsuccessful.


Because our Department is responsible for services to current and former foster youth, ages 16 – 21, in-house collaboration to serve this population was quite successful—particularly in the utilization of the WTW Grant Matching Funds. This enhanced service was accomplished through a three-step process:

- First, case managers were educated as to the basic 15% WTW Grant and WTW Grant Matching Funds eligibility criteria.
- Second, case managers were asked to review their caseloads and make referrals to grant staff.
- Third, grant staff met with the prospective clients, made eligibility determinations, and delivered services for those that were eligible.

For the current 01/02 fiscal year, we are continuing to make WTW Grant Matching Fund eligibility determinations with former foster youth, ages 18 to 25.
