Pouh tong, meih box nyei jaa-dorngx zoux bun meih maiv duqv zipv baeqc nyaanh. Leiz gorngv Nquenc kungx dimv mangc taux meih nyei jaa-dorngx juqv hlaax yietc nzunc. Naaiv maaiah eix-leiz gorngv yie mbuo maiv tiuv meih nyei baeqc nyaanh naaiv nzunc aqv.

[] Meih da'nyeic nzunc nyei sou-box se yiem hnyangx-dong borqv sou-gorn wuov. Yietc zungv sou-fienx oix zuqc box bun hiuv caux dimv mangc yiem meih nyei (SAWS 2) borqv sou-gorn nyei sou.

[] Meih da'nyeic nzunc nyei sou-box se yiem meih Ndaamv-Hnyangx Box Fienx (SAR 7) nyei Sou.

Meih bun sou-dengv yie mbuo taux meih nyei jaa-dorngx caux jaa-zinh. Meih maiv zuqc aengx box nzunc naaiv norm jaa-dorngx aqv, cuotv liuz maaiah tiuv nyei jauv hhangv.
