This notice is to inform you that the California Department of Social Services (CDSS) will distribute the CCTF’s Kids’ Plate revenue allocated by the State Fiscal Year (SFY) 2013-2014 Budget Act. The total distribution for SFY 2013-14 is \$963,000. Each county’s share is based on their proportion of each county’s population of children ages zero to 18 as reported by Department of Finance July 2013 statistics. The allocations for the fiscal year are shown on the enclosed chart (Attachment A).

Pursuant to California Welfare and Institutions Code (WIC) Section 18967, the purpose of the CCTF is to fund child abuse and neglect prevention and intervention programs operated by private nonprofit organizations or public institutions of higher education with recognized expertise in fields related to child welfare. Under WIC Section 18983, CCTF monies are also used to fund Child Abuse Prevention Coordinating Councils (CAPCs). The intent of the Kids’ Plate revenue is to strengthen health and safety protections for children and to help fund programs to reduce child injury and child abuse.

The California Department of Motor Vehicles generates the Kids’ Plate revenue from initial and renewal fees for custom and sequential California “Kids” vehicle license plates. Pursuant to California Vehicle Code Section 5072, Kids’ Plate revenue is deposited into the Child Health and Safety Fund. WIC Section 18285(e) (1) provides up to 25 percent of the monies to fund child abuse prevention programs (22.5 percent to the County Children’s Trust Fund and 2.5 percent to the State Children’s Trust Fund). The remaining monies are to be used for licensing activities related to the Child Care program of the Community Care Licensing Division within CDSS, and for childhood injury prevention programs and activities.

To facilitate your efforts toward preventing child abuse and neglect and in early intervention, we encourage you to coordinate the use of the Kids' Plate revenue with other funding sources such as Child Abuse Prevention, Intervention and Treatment, Community-Based Child Abuse Prevention, and Promoting Safe and Stable Families funds.
