This CFL provides claiming information for the new TCVAP aid code R1, which was established to correctly identify and track cash assistance expenditures of California Work Opportunity and Responsibility to Kids (CalWORKs) TCVAP trafficking victims as stated in ACL No. 13-25.

Claiming Instructions

County Expense Claim (CEC)

There are no changes in the way counties claim TCVAP administrative costs on the CEC as a result of aid code R1. Counties should continue to follow the claiming instructions in CFL No. 11/12-38.

County Assistance (CA) 800 Claim Information

Aid code R1 has been added to the CA 800A NONFED claim (see attachment) effective with the June 2013 claiming month. The following is a description of aid code R1:

Aid Code R1: CalWORKs TCVAP Trafficking Victims

- This code applies to non-citizen CalWORKs TCVAP trafficking victims who are
 undocumented or otherwise ineligible for federally-funded benefits and services
 due to immigration status. This includes CalWORKs TCVAP noncitizen victims of
 trafficking who are in the process of applying for a T Visa; have applied for a
 T Visa; or are taking steps to become certified by the Office of Refugee
 Resettlement for federal benefits.
- Expenditures claimed using this aid code have a cost sharing ratio of 97.5 percent General Fund and 2.5 percent county funds.
