COUNTY FISCAL LETTER (CFL) NO. 14/15-05

SUBJECT: FISCAL YEAR (FY) 2014-15 CALIFORNIA WORK OPPORTUNITY

AND RESPONSIBILITY TO KIDS (CALWORKS) FAMILY

STABILIZATION (FS) ALLOCATION

REFERENCE: ASSEMBLY BILL (AB) 74 (CHAPTER 21, STATUTES OF 2013)

ACL NO. 14-12, DATED FEBRUARY 4, 2014 CFL NO. 13/14-35, DATED FEBRUARY 5, 2014

This letter notifies counties of the CalWORKs FS allocation for FY 2014-15. A total of \$26.8 million in federal Temporary Assistance for Needy Families funds and General Fund was made available upon approval of the Budget Act of 2014.

FS is a component of the CalWORKs program that provides intensive case management and services to address immediate crisis situations and needs. As indicated in Welfare and Institutions Code section 11325.24, effective January 1, 2014, CalWORKs recipients shall be eligible to participate in FS if a county determines that a family is experiencing an identified situation or crisis that is destabilizing the family and would interfere with participation in Welfare-to-Work (WTW) activities and services. Funds allocated for FS shall be in addition to and independent of the county Single Allocation. County Welfare Departments may, at their discretion, also utilize Single Allocation funds to provide housing and other needed services to families participating in FS. Additional information on this program was issued on February 4, 2014, in All County Letter No. 14-12.

In consultation with the County Welfare Directors Association, the \$26.8 million is allocated in Attachment I as follows:

- Fifty percent of the funds were distributed based on a percent to total of each county's average employment services monthly caseload for the most recent 12 months from May 2013 through April 2014 as reported on the CalWORKs WTW Monthly Activity Report All (Other) Families (WTW 25) and the CalWORKs WTW Monthly Activity Report Two-Parent Families (WTW 25A).
- The remaining fifty percent was distributed based on a percent to total of each county's FY 2013-14 combined allocation for CalWORKs Eligibility Administration, WTW Employment Services and Stage One Child Care.

Counties should claim costs to Program Code (PC) 884 – FS–Federal and PC 885 – FS–Non-Federal. Expenditures exceeding the allocation will be shifted to county-only funding via State Use Only Code 886 – FS Overmatch.
