ALLOCATION FOR THE PROMOTING SAFE AND STABLE

FAMILIES PROGRAM

This errata is to inform counties of the revised Fiscal Year (FY) 2014-15 Promoting Safe and Stable Families (PSSF) allocation. An additional \$603,444 in Federal Title XX funds is added to the allocation provided in County Fiscal Letter (CFL) No. 14/15-06 for a total allocation of \$28,613,512.

<u>CFL No. 14/15-06</u> inadvertently used incorrect data related to the total number of children ages zero to seventeen. By recalculating this portion of the allocation, it was determined that several counties received less than what they would have received while several other counties received more.

The California Department of Social Services is now allocating the \$603,444 to those counties that received less than the appropriate amount based on the recalculated caseload. Attachment I displays the revised FY 2014-15 PSSF allocation. As noted above, the additional funding will be provided with federal Title XX funds. The counties that received more than they would have with the correct caseload will not have their allocations adjusted.

For the impacted counties identified in Attachment I, please continue to use the program codes listed in <u>CFL No. 14/15-06</u> for costs up to the original allocation. Costs that exceed the original allocation will be funded with Title XX funding. State Use Only (SUO) codes will be utilized at the state level to move costs from PSSF to Title XX during the September 2014 adjustment claim process.

Expenditures exceeding the total combined federal fund allocation will be transferred to county share using SUO code 521(SUO-PSSF).
