EMERGENCY FOOD ASSISTANCE PROGRAM (EFAP) COORDINATORS

SUBJECT: FEDERAL FISCAL YEAR (FFY) 2014 SUPPLEMENTAL ALLOCATION

The EFAP is pleased to announce that there is supplemental funding available to food banks that have allowable unreimbursed administrative expenses incurred October 1, 2013 through September 30, 2014.

The supplemental funding is comprised of funds set-aside by the EFAP for emergency purposes, unspent funds by food banks, unspent state operational expenses, and unspent funds re-allocated from other states. The amount of supplemental funding available for FFY 2014 is \$797,741.30. Funding is allocated based on the 60/40 formula; 60 percent of the number of persons in the households within the county having income below the federal poverty level (based on the 2010 census data), and 40 percent of the number of unemployed persons within the county (obtained annually from the Employment Development Department). Additionally, for food banks whose portion of the supplemental funding allocation was more than their unpaid allowable expenses, the allocation was adjusted to the amount of eligible expenses and remaining funds were redistributed to other food banks with allowable expenses. Please see the attachment for your food bank's supplemental allocation.

A Supplemental Allocation Request for Reimbursement of Expenses has been emailed to you by your CDSS EFAP Program Consultant. Please return by mail your hardcopy request with an original signature. The requests should be mailed to the EFAP at: 744 P Street, Mail Station 19-51, Sacramento, CA 95814. Please note that supporting documentation is not required for this reimbursement request.

The deadline to submit a claim for reimbursement is December 5, 2014. Food banks that have not submitted a claim by December 5, 2014 will lose their supplemental funding.
