SUBJECT: FISCAL YEAR 2014-15 CALIFORNIA WORK OPPORTUNITY

AND RESPONSIBILITY TO KIDS SINGLE ALLOCATION

AUGMENTATION AND REDISTRIBUTION

REFERENCE: CFL NO. 14/15-21, DATED OCTOBER 3, 2014

This letter informs counties of the Fiscal Year (FY) 2014-15 augmentation and redistribution for the California Work Opportunity and Responsibility to Kids (CalWORKs) Single Allocation (SA) program.

In consultation with the County Welfare Directors Association (CWDA), an augment of \$15.8 million is allocated (in Attachment I) to the CalWORKS SA program based on the 2015-16 Governor's Budget as follows:

- An increase of \$24.3 million is distributed across three of the program components: Stage One Child Care, Welfare-to-Work Employment Services and Eligibility Administration based on a percent to total of the FY 2014-15 allocations for the three components.
- Due to updated actuals for Cal Learn caseload, a reduction of \$8.5 million for the Cal Learn component is distributed based on a percent to total of each county's FY 2014-15 Cal Learn allocation.

Additionally, to ensure maximum expenditure of available program funding, the CWDA has determined a redistribution of funding among the counties, as displayed in Attachment I.
