This letter informs counties of an augmentation and redistribution for the Fiscal Year (FY) 2014-15 CalFresh Program Administrative allocation.

In consultation with the County Welfare Directors Association (CWDA), an augment of \$130,000 General Fund was distributed to counties based on a percent to statewide total of the FY 2014-15 CalFresh Program Administrative base allocation, as reflected in [County Fiscal Letter \(CFL\) No. 14/15-20](#). In addition, to ensure maximum expenditure of available program funding, the CWDA has determined a redistribution of unspent funding among the counties as displayed in the attachment to this letter.

The amounts displayed on the attachment reflect each county's revised CalFresh Program Administrative allocation based on the 2015-16 Governor's Budget. For further details on the appropriation amounts and claiming instructions please refer to [CFL No. 14/15-20](#).
