SUBJECT: FISCAL YEAR 2016-17 NON-MEDICAL OUT-OF-HOME CARE

GENERAL FUND ALLOCATION

This letter informs counties of the Fiscal Year (FY) 2016-17 allocation for Non-Medical Out-of-Home Care (NMOHC) certification costs related to the Supplemental Security Income/State Supplementary Payment (SSI/SSP). A total of \$352,000 General Fund (GF) is available based on the Budget Act of 2016, as shown in the attachment.

The FY 2016-17 NMOHC administrative allocations were distributed based on a percent to statewide total of each counties the FY 2015-16 NMOHC allocation.

Administrative costs associated with the NMOHC funds are to be reported on the County Expense Claim to Program Code 135 (SSI/SSP Out-of-Home Care). Costs exceeding the GF allocation will be shifted to county-only funding using State Use Only Code 833.
