## REFERENCE:

This is to advise you that the California State Department of Social Services (SDSS) in conjunction with the Western Region, Food and Nutrition Service, United States Department of Agriculture (USDA), is presently conducting a follow-up study on the recently concluded Food Stamp "Cash-In" Program for California SSI/SSP recipients. The evaluation project will require more than 800 home visit interviews with SSI/SSP recipients statewide by designated SDSS and USDA personnel.




