REVISED FOOD STAMP FORMS: DFA 377.7B, "FOOD STAMP REPAYMENT NOTICE FOR INADVERTENT HOUSEHOLD ERRORS ONLY;" DFA 377.7B1, "FOOD STAMP REPAYMENT NOTICE FOR INADVERTENT HOUSEHOLD ERRORS ONLY, FINAL NOTICE;" DFA 377.7C, "FOOD STAMP REPAYMENT AGREEMENT FOR INADVERTENT HOUSEHOLD ERRORS ONLY;" and DFA 377.7D, "FOOD STAMP REPAYMENT NOTICE FOR ADMINISTRATIVE ERRORS ONLY;" and NEW FORMS: DFA 377.7F, "FOOD STAMP REPAYMENT NOTICE FOR AN INTENTIONAL PROGRAM VIOLATION ONLY;" DFA 377.7F1, "FOOD STAMP REPAYMENT NOTICE FOR AN INTENTIONAL PROGRAM VIOLATION ONLY, FINAL NOTICE;" and the DFA 377.7G, "FOOD STAMP REPAYMENT AGREEMENT FOR AN INTENTIONAL PROGRAM VIOLATION ONLY."

This letter transmits copies of four revised and three new Repayment Notice/Agreement forms. The four revised forms are:

- o DFA 377.7B, "Food Stamp Repayment Notice for Inadvertent Household Errors Only:"
- o DFA 377.7B1, "Food Stamp Repayment Notice for Inadvertent Household Errors Only, Final Notice;"
- o DFA 377.7C, "Food Stamp Repayment Agreement for Inadvertent Household Errors Only;" and
- o DFA 377.7D, "Food Stamp Repayment Notice for Administrative Errors Only."

The three new forms are:

- o DFA 377.7F, "Food Stamp Repayment Notice for an Intentional Program Violation Only;"
- o DFA 377.7F1, "Food Stamp Repayment Notice for an Intentional Program Violation Only, Final Notice;" and
- o DFA 377.7G, "Food Stamp Repayment Agreement for an Intentional Program Violation Only."

The penalty statement on the four revised forms has been changed as specified below.

o On the DFA 377.7B, B1, and C the statement, "If you are convicted of fraud, penalties will apply even if you agree to pay back what you owe," has been revised to say "If this inadvertent household error is later found to be an intentional program violation, penalties will apply even if you agree to pay back what you owe."

o On the DFA 377.7D, the statement, "If you are convicted of fraud, penalties will apply even if you agree to pay back what you owe," has been deleted. (No changes have been made to the DFA 377.7E, "Food Stamp Repayment Agreement for Administrative Errors Only.")

The three new Repayment Notice/Agreement forms were developed to address specific terms of repayment for intentional program violations. These three new forms are the DFA 377.7F, "Food Stamp Repayment Notice for an Intentional Program Violation Only;" the DFA 377.7F1, "Food Stamp Repayment Notice for an Intentional Program Violation Only, Final Notice;" and the DFA 377.7G, "Food Stamp Repayment Agreement for an Intentional Program Violation Only."

### STOCK

The California Department of Social Services (CDSS) warehouse will no longer stock the earlier versions of the DFA 377.7B, B1, C, and D. Counties may continue to use the current stock (4/93) of the DFA 377.7B, B1, C, and D until the revised notices are available.
