TO: ALL COUNTY WELFARE DIRECTORS

SUBJECT: STANDARD UTILITY ALLOWANCE (SUA) FOR FEDERAL FISCAL YEAR (FFY) 1995


In accordance with Food Stamp Manual Section 63-502.353(d), the Standard Utility Allowance (SUA) has been adjusted to reflect changes in the cost-of-living. The new SUA will be \$147 effective October 1, 1994. (The October 1 effective date is the result of a recent regulatory change to provide consistency with the timing of other Food Stamp cost-of living adjustments.) It must be applied to all Food Stamp cases that use the SUA so that the October 1994 allotment reflects the increased amount. This change is based upon an increase in the Fuel and Other Utilities Component of the Consumer Price Index for All Urban Consumers (CPI-U).

In order to comply with the requirements for mass change, the County Welfare Departments (CWDs) must inform Food Stamp households of this change and its effective date. Reference copies of the general notice, Notice To All Food Stamp Recipients (FS 5 and FS 5 [SP]), are attached to this letter. CWDs may obtain camera-ready copies of the English and Spanish versions of the general notice by contacting the Forms Management Unit at (916) 657-1907 or CALNET 437-1907. CWDs may reformat the English language version to accommodate specific county systems. Translations in Chinese, Lao, Cambodian, and Vietnamese will be forwarded to the County Forms Coordinator by the Language Services Bureau when available.

CWDs are encouraged to mail a copy of the general notice to all Food Stamp households with the October allotment. Those CWDs that do not mail a copy of this general notice to all households must utilize the news media or post this information in certification offices, issuance locations or other sites frequented by certified households. If any other change is to be effective with the October allotment, the Food Stamp Notice of Change (DFA 377.4) must be used to provide individual notice to the household.

The SUA amount will be changed in the Food Stamp Handbook Section 63-1101.26 to reflect this adjustment and the revision will be released separately.

NOTICE TO ALL FOOD STAMP RECIPIENTS

(October 1, 1994 Standard Utility Allowance Increase)

As of October 1, 1994 the Standard Utility Allowance (SUA) is raised from \$145.00 to \$147.00. The United States Department of Agriculture (USDA) has approved this raise, which is based upon a change in the Consumer Price Index.

If the SUA is used as part of your shelter deduction AND if you have had no other changes in your Food Stamp case, your Food Stamp benefits may be raised. If you have had other changes in your Food Stamp case, you will receive a separate notice which includes this raise.

If you think we made a mistake in your October allotment because of the SUA raise, you may ask for a state hearing. Your request may be written or verbal, but it must state that you want a hearing and why you think this action is wrong. Your request for a state hearing must be made within 90 days of the date of this action.

**AVISO A TODAS LAS PERSONAS QUE RECIBEN
ESTAMPILLAS PARA COMIDA**
(Aumento de la Cantidad Normal Permitida por Servicios Públicos y Municipales
del 1 de octubre de 1994)

A partir del 1 de octubre de 1994, se aumentará la Cantidad Normal Permitida por Servicios Públicos y Municipales (SUA) de \$145.00 a \$147.00. El Departamento de Agricultura de los Estados Unidos (USDA) ha autorizado este aumento. Este cambio está basado en un cambio en el índice de precios al consumidor.

Si se usa la SUA como parte de su deducción por vivienda Y si no ha tenido otros cambios en su caso de estampillas para comida, es posible que se aumenten sus beneficios de estampillas para comida. Si ha tenido otros cambios en su caso de estampillas para comida, recibirá otra notificación por separado que incluye este aumento.

Si cree que cometimos un error en su asignación para octubre a causa del aumento de la SUA, puede solicitar una audiencia con el estado. Su petición puede ser por escrito u oralmente, pero debe indicar que desea una audiencia y por qué cree que esta acción está equivocada. Su petición para una audiencia con el estado debe ser presentada dentro de los 90 días siguientes a la fecha de esta acción.
