ALLOCATION (SA) AUGMENTATION

REFERENCE: CFL NO. 10/11-10, DATED NOVEMBER 16, 2010

This letter informs counties of the FY 2010-11 augmentation for the CalWORKs SA. The amounts identified on the attachments reflect the revised CalWORKs SA for FY 2010-11 based on the Governor's Budget.

Attachment I displays the revised allocation for each of the four program components: CalWORKs Eligibility Administration, CalWORKs Welfare-to-Work Employment Services, Cal Learn, and CalWORKs Child Care.

Attachment II provides a summary of the CalWORKs Eligibility augmentation. A \$12.5 million adjustment was distributed based on a percent-to-total of each county's average monthly caseload growth from October 2008 through September 2009 and October 2009 through September 2010. Counties with no or negative growth are held harmless to their FY 2010-11 Eligibility allocation as indicated in CFL No. 10/11-10.

Attachment III provides a summary of the Cal Learn augmentation. A \$2.2 million adjustment was distributed based on a percent-to-total of each county's average monthly caseload growth from October 2008 through September 2009 and October 2009 through September 2010 as reported on the STAT 45 Report. Counties with no or negative growth are held harmless to their FY 2010-11 Cal Learn allocation as indicated in CFL No. 10/11-10.

Attachment IV provides a summary of the CalWORKs Child Care augmentation. A \$5.5 million Child Care increase due to later implementation of the Exempt Care Reduction was distributed based on a percent-to-total of each county's FY 2010-11 Child Care allocation as indicated in CFL No. 10/11-10.

Attachment V exhibits a revised listing of Program Codes (PCs) available for claiming to the CalWORKs SA. Expenditures charged against these PCs are tracked against the CalWORKs SA ledger on the quarterly County Expense Claim.
