## **FAMILY CHILD CARE HOME NOTIFICATION OF PARENTS' RIGHTS**

## **PARENTS' RIGHTS**

As a Parent/Authorized Representative, you have the right to:

- 1. Enter and inspect the family child care home without advance notice whenever children are in care.
- 2. File a complaint against the licensee with the licensing office and review the licensee's public file kept by the licensing office.
- Review, at the family child care home, reports of licensing visits and substantiated complaints 3. against the licensee made during the last three years.
- 4. Complain to the licensing office and inspect the family child care home without discrimination or retaliation against you or your child.
- 5. Be notified and receive, from the licensee, a written notice that lists the name of any person not allowed in the family child care home while children are present. (NOTE: This notice is only required when the Department has, in writing, excluded someone from the family child care home on or after January 1, 2001).
- 6. Request in writing that a parent not be allowed to visit your child or take your child from the family child care home, provided you have shown a certified copy of a court order.
