Notice of the Title 24 Part 2, 7, 9 - 45-Day Public Comment Period

April 3, 2026 - May 18, 2026

The California Building Standards Commission (CBSC), on its own behalf and that of the Division of the State Architect, Office of Statewide Hospital Planning and Development, and Office of the State Fire Marshal, is providing notice of code changes intended for inclusion in the Intervening Supplement to the 2025 California Building Standards Code, Title 24, which is scheduled for publication on January 1, 2027, with an effective date of July 1, 2027. The regulations were heard by the Health Facilities Code Advisory Committee and Building, Fire and Other/Structural Design and Lateral Forces Ad Hoc Code Advisory Committee.
